OpenPOWER Foundation may elect to avail itself of certain protections offered by the National Cooperative Research and Production Act of 1993, as amended, which requires disclosure of the names of all members of OpenPOWER. Accordingly, the undersigned hereby authorizes such person who is the President or Chairperson (or acting President or Chairperson of OpenPOWER Foundation) to act as the undersigned's true and lawful attorney-in-fact and authorizes him or her to (1) notify government agencies of the undersigned's membership in OpenPOWER, (2) make, approve the form of, execute and deliver filings with government agencies on behalf of OpenPOWER and on behalf of the undersigned as a member of OpenPOWER indicating such membership, (3) receive notifications, including without limitation, notifications pursuant to the National Cooperative Research and Production Act on behalf of OpenPOWER and on behalf of the undersigned as a member of OpenPOWER, and (4) authorize and direct other officers of, and/or counsel to OpenPOWER, to do any of the foregoing acts. OpenPOWER will forward to the undersigned any notifications that it receives which are other than normal confirmations of filings and other administrative notices relating to all members.
